OFFICE ORDER

In pursuance of Council's No. F 1(4)/2017-Per.IV dated March 27th, 2018, under the provision as contained therein, the recommendations of 7th Central Pay Commission have been adopted in respect of scientific employees of ICAR and implemented by the Council. Revised pay structure would be admissible to those scientific employees who opt for the same in accordance with the extent Rules. Accordingly, as approved in ICAR letter dated 27th March'2018, all the scientific employee may submit the option in the prescribed format (annexed herewith) to opt the 7th CPC pay scales alongwith undertaking in the matter of excess payment on account of fixation of pay under 7th CPC pay structure. As such, their option for opting 7th CPC and undertaking required to be submitted by each and every scientific employee (Principal Scientist, Sr. Scientist and Scientist) positively by 7th of April'2018 to the undersigned for further necessary action for drawl of their salary from the month of April'2018 as per their fixation/fitment of pay in new pay scale(s) or otherwise it would not be possible at the end of office to draw their salary in new pay scale as recommended by 7th Central Pay Commission/ICAR
